# From the President

Why study music? As music teachers we innately know the answer to this question. Some of the benefits of instrumental study involve sharpening fine motor skills and hand-eye coordination for young students. For older students, playing or singing can reduce anxiety and blood pressure.

I have a student who is 81 years old. She is from Germany and came to the United States about 30 years ago. She took piano lessons as a child and describes walking through the rubble from World War II for an hour each week to get to her lesson. As she grew older, school and career consumed her life and she was not involved with music at all.

About a year ago she contacted me about lessons. When I arrived at her house, she showed me her original German piano books, the pages yellowed and crumbling around the edges. I saw the markings of her teacher, and she played some of the pieces that she had learned. She immediately knew when she had played a wrong note, and she often sang the melody.

Her wedding anniversary was in early September, and she and her husband had planned a trip to Hawaii. She told me that she would not be available for lessons for about three weeks. To my surprise, I received a text from her about two weeks later requesting a lesson. Unfortunately, a hurricane warning had been issued and they had to cancel their trip. Two days later her husband developed severe bronchitis. Then she received a call from Germany that her older brother had suffered a fall and broken his hip and right shoulder.

She concluded the text with, "I am very sad! Only music can help...!" This may indeed be the best reason to study music, because sometimes only music can help.

# NFMC UPDATES

#### Jr. Club Registration Information:

All Jr. Club Dues are due no later than October 15<sup>th</sup>, 2025. Dues received late are automatically assessed a \$50 late fee.

Our Georgia NFMC officers are requesting that all Jr. Club Dues are submitted online along with online payments. If you have printed the form and sent checks in the past, please know that our Georgia NFMC respectfully requests that we no longer send paper forms and checks. Please follow the steps below to register your Jr. Club for your District Festival. I have also created a brief video tutorial for you if you prefer to see the steps in video form. (It is 7 mins)

- 1) Go to <a href="https://georgianfmc.org">https://georgianfmc.org</a>
- 2) Select 'Membership' and drop down and click on 'Membership' Area'
- (If prompted for a password enter: georgiapeach)
- 3) Select the link for Jr Club Registration Form
- 4) Complete the online Form

the name of the Junior Club is your studio name or your name (whatever you have used in past years)

enter your name for Counselor/Teacher

enter [Central, West, or North] Gwinnett for your GFMC Senior

enter [Central, West, or North] Gwinnett for the Festival in which your Jr Club members participate

enter one student name at a time (alphabetically) and click Add New to continue entering student names for all students who will be participating from your studio

your total fee will be automatically calculated, so click on 'Proceed to Payment Screen' to make a secure Credit Card payment for your Jr. Club Registration

5) You will receive a confirmation email from GFMC with your payment and roster listed. You are to forward this to your festival chair. No handwritten or typed rosters to your chairman are acceptable.

That's it! Your Jr. Club will be registered. Remember that the deadline to register your Jr. Club student rosters and payment online is October 15th, 2025.

The GCMTA sponsors a Music Day festival every November. The purpose of this festival is to encourage study and to provide an opportunity for students to perform and receive an evaluation of their performance and cash awards. Proceeds from Music Day are used to provide funds for scholarships and to support the budget.

Registration Deadline: Submitted online by Friday, October 17, 2025

Registration Fee Postmark Deadline: Wednesday, October 22, 2025

In-Person Performance Date: Saturday, November 15, 2025 Virtual Performance Submission Deadline: Tuesday, November 11, 2025

A filled-in rating sheet and print copy of the music must be provided to Kathy Dawal by Saturday, November 8, 2025.

Entry Fee: \$25.00 per student, plus \$10 each additional instrument.

#### Teacher Requirements:

- Teachers entering students in Music Day must have all dues confirmed as paid.
- 2. All teachers entering students in Music Day are required to work the event on the following basis:
  - a.7 or fewer students: work ½ day, assist with setting up or clean up.
  - b.8-14 students: work a full day, assist with clean up.
  - c.15 or more students: work a full day and assist in an administrative role.
- 3. Teacher work requirements are mandatory regardless of student cancellations; however, a teacher may pay an exemption fee of \$50 for ½ day, \$100 for a full day, or a teacher may send an approved adult substitute.
